INT. COURTROOM - MORNING

JUROR 1

JUROR 1

Sorry judge, that's just what I do. You see I'm an actor, writer, stand-up comedian with a background in improv from the Upright Citizens Brigade and Second City. As an upright citizen in this city court I feel I bring-

Judge bangs her gavel.

JUDGE

No yes, anding in my courtroom, juror! You're here to help uphold justice.

JUROR 1

I'm here to serve the audience, perform guerrilla theater at all times. My calling in life.

JUDGE

No more outbursts. How does the defendant plea?

TOM PELICAN

Your honor I am not guilty. I promise.

JUROR 1

Yeah, that's what they all say down at the station.

JUDGE

Alright, bring forth the evidence.

A bloody knife in a Ziplock bag is presented.

TOM PELICAN

I don't see what my bloody knife has to do with this case.

JUROR 1

Well you clearly own a lot of bloody knives. A lot of dirtied weapons. You dirty, dirty boy.

TOM PELICAN

What? Aren't you supposed to be my unbiased peer? Where the hell is this coming from?

JUROR 1

Well, if it's true you own a bloodied knife, then what else is true? Huh? Some filthy little secrets you'd like to reveal now? That might make things a little more amusing around here.

Judge bangs her gavel.

**JUDGE**

DEFENSE ATTORNEY

No your honor. The autopsy results showed poison on both counts. This "evidence" is completely erroneous. There's no law against owning a bloody knife.

JUROR 1

That was good but try saying it again, with more conviction this time. Maybe cry too.

JUDGE

Ok let's see the rest of the evidence.

A WITNESS is called to the stand.

PROSECUTING ATTORNEY
You worked with him at the same
diner and witnessed the killings?

WITNESS

JUROR 1

Everyone leaves the court. Beat. Everyone returns.

JUDGE

JUROR 1

We the jury, by the power vested in us by the court, have decided Tom Pelican is guilty. Mr. Pelican murdered 3 people, with 3 bloody knives, in 3 different libraries.

DEFENSE ATTORNEY
Objection! My client was not being tried for...well any of that.
(MORE)

DEFENSE ATTORNEY (CONT'D)

ALLEGEDLY! And there were no mentions of libraries.

JUROR 1

Yeah well we decided to punch it up. Rule of threes works anywhere really, a courtroom is no exception. And library sounds like Clue, that movie was comedy gold. So triple homicide it is haha.
